Quarter 1 Awards

Award: Smedley Award

Criteria:

- Add 5 new, dual or reinstated members between 1st August, 2022 to 30th September 2022.

Eligibility:

- Applications and payments before end dates as above at TI

Process:

- These are awards from TI.

Recognition:

- Award Ribbons from TI.

Award: Monsoon Dhamaka

Criteria:

- Add 10 new, dual or reinstated members between 1st July, 2022 and 30th September, 2022. No transfer or charter members to be included

Eligibility:

- Applications and payments to TI before 30th September, 2022.

Process:

- Data will be verified from the dashboard.

Recognition:

- Award for the President and VP-Membership of first term.

Award: The Power of Three

Criteria:

- New or Dual or Reinstated member joining a club between 1st July, 2022, to 30th September, 2022 and paying membership fees till 30th September, 2023.

Eligibility:

- Membership start date should be 1st July, 2022, or 1st August, 2022, or 1st September, 2022, and paid to TI before 30th September, 2022.

Process:

- Data will be verified from the membership report.
- VP-Membership to submit through the form on behalf of the member by 15th October, 2022.

Recognition:

- TI branded merchandise for the member.

Award: The Power of Two

Criteria:

- New or Dual or Reinstated member joining a club between 1st July, 2022 to 30th September, 2022 and paying membership fees till 31st March, 2023.

Eligibility:

- Membership start date should be 1st July, 2022 or 1st August, 2022 or 1st September, 2022 and paid to TI before 30th September, 2022.
- Member is not eligible for “The Power of Three” award

Process:

- Data will be verified from the membership report.
- VP-Membership to submit through the form on behalf of the member by 15th October, 2022.

Recognition:

- TI branded merchandise for the member

Award: Torch Bearer

Criteria:

- Clubs in which minimum 10 members do annual renewals, during the September renewal cycle before 31st October, 2022.

Eligibility:

- Membership fees needs to be paid for 1st October 2022 to 30th September 2023.

Process:

- Data will be captured from the membership report.
- VP-Membership to submit the form before 15th November, 2022.

Recognition:

- Plaque for the club.

Award: Old is Gold Award

Criteria:

- Retain and renew 80 % base members (and not Membership Count)by 15th October, 2022

Eligibility:

- Members part of the base membership (i.e., 1st July, 2022) will only be considered.
- Club to be in good standing, and base membership needs to be 15 or above.

Process:

- Data will be captured from the membership report.

Recognition:

- TI branded Merchandise for all ExCom members.

Award: Rising Star Award

Criteria:

- Clubs with membership 8 to 19 as of 1st July, 2022 adding net 5 or more members by 15th October, 2022

Eligibility:

- Membership start date should be 1st July, 2022 or 1st August, 2022 or 1st September, 2022.

Process:

- Verified through dashboard.

Recognition:

- Award for the Club.

Award: Come Back Award

Criteria:

- Add 5 reinstated members between 1st July, 2022 to 31st December, 2022.

Eligibility:

- Membership start date should be between 1st July, 2022 and 1st December, 2022.

Process:

- Data will be captured from dashboard.
- VP-Membership to submit the form by 31st December, 2022.

Recognition:

- Recognition for the Club which adds 5 or more reinstated members.
- TI branded merchandise for every reinstated member(s) irrespective of total such member(s) added in the club.

Annual Awards

Award: Growth Leader Award

Criteria:

- Member generated club lead that gets chartered during the program year.

Eligibility:

- The member getting the lead should also take up the Sponsor role for the Club.
- The member should attend club sponsor training program.
- Not eligible for Super Growth Leader Award

Process:

- Data will be verified from the dashboard.
- The member details should be communicated by the Division Director to CGD within a month of chartering.

Recognition:

- Trophy for the member.

Award: Super Growth Leader Award

Criteria:

- Member generated club lead that gets chartered during the program year.

Eligibility:

- The member getting the lead should also take up the Sponsor role for the Club.
- He / She should enlist 25 members (20 chartered , plus another five)
- The member should attend club sponsor training program.

Process:

- Data will be verified from the dashboard.
- The member details should be communicated by the Division Director to CGD within a month of chartering

Recognition:

- Trophy for the member.

Award: Helping Hand Mentor Award

Criteria:

- Mentors who help new clubs chartered during 2021-2022 or 2022-2023 to have 20 or more members till 30th June 2023

Eligibility:

- Mentors of clubs appointed last year and this year.
- Mentor should attend Mentor Training Program

Process:

- Data will be verified from the dashboard.

Recognition:

- Award for Mentor(s)

Award: Helping Hand Coach Award

Criteria:

- Coaches who help assigned clubs show either 5 members growth or 5 DCP points by 30th June, 2023.

Eligibility:

- Coaches from previous year as well as appointed this year
- Coaches should attend Coach training Program

Process:

- Data will be verified from the dashboard.

Recognition:

- Award for Coache(s).
