#### **Process:**

Data will be verified from the membership report.

# **Recognition:**

TI merchandise for VP-Membership

# **Award: Fast Forward Talk Up**

#### Criteria:

- Club to add 5 New or Dual or Reinstated members in Feb 2023 or in Mar 2023
- Clubs adding 5 members each in Feb and Mar will be eligible for two recognitions

### **Eligibility:**

- Payment needs to be completed to TI by 28 Feb or 31 March 2023
- Club not eligible for Rising Star award.

#### **Process:**

Data will be verified from the dashboard and TI membership reports page

# **Recognition:**

TI merchandise for club (for each month)



# **Award: Renewal Champs**

#### Criteria:

Club to complete 80% of their 1st Jan 2023 base membership renewals before 28th Feb/10th Mar/ 20th March 2023.

### **Eligibility:**

Active clubs with membership 12 or more as of 1<sup>st</sup> Jan 2023

#### **Process:**

Data will be verified from the dashboard

# **Recognition:**

- Criteria achieved by 28th Feb 2023 TI Merchandise for entire Executive Committee + Plaque for Club
- Criteria achieved by 10th Mar 2023 TI Merchandise for Treasurer and for Club
- Criteria achieved by 20th Mar 2023 TI Merchandise for Club

# **Award: Level Up**

#### Criteria:

• Club with membership below 8 as on 1st Jan 2023 to become an 'active' club on or before 31st Mar 2023 and continue to remain 'active' on 15th Apr 2023

# **Eligibility:**

'Inactive' clubs as on 1st Jan 2023

#### **Process:**

Data will be verified from the dashboard.

# **Recognition:**

- TI Merchandise for all members active on 15th April 2023
- Plaque for the club

# **Award: Sustainable Club**

#### Criteria:

• Club with membership base between 8 and 12 on 1st Jan 2023 completes minimum 8 renewals by 31st March 2023

# **Eligibility:**

- Active clubs with membership between 8 and 12 as of 1st Jan 2023
- Not eligible for Rising Star award

#### **Process:**

Data will be verified from the dashboard

### **Recognition:**

TI Merchandise for Club President and VP-Membership.

# **Award: Power of Two Returns**

#### Criteria:

 New or Dual or Reinstated member joining a club between 1st Jan 2023 and 31st Mar 2023, and paying membership fees till 30th Sep 2023

# **Eligibility:**

Membership start date should be 1st Jan 2023 or 1st Feb 2023 or 1st Mar 2023 and paid to TI on or before 31st Mar 2023

#### **Process:**

Data will be verified from the membership report.

### Recognition:

- TI merchandise for the member
- If 5 or more members qualify for this award, TI merchandise for VP-Membership

# Award: Rising star (Continued from CGD-Q2-Awards)

#### Criteria:

- Club membership between 8 and 13 (as on 1 Nov 2022) adds 5 members by 31st March 2023 and club renews minimum 80% of members by 1st April 2023
- Club membership between 13 and 17 (as on 1 Nov 2022) reaches 20 members by 31st March 2023 and club renews minimum 80% of members by 1st April 2023

### **Eligibility:**

Membership start date should be between November 2022 and March 2023 and membership renewed for next term by 31st Mar 2023 to TI.

#### **Process:**

Data will be captured from the dashboard.

### **Recognition:**

Trophy for the club
