Quarter 1 Awards

Award: Smedley Award

Criteria:

- Add 5 new, dual or reinstated members between 1st Aug 2023 to 30th Sep2023.

Eligibility:

- Applications and payments before end dates as above at TI

Process:

- These are awards from TI.

Recognition:

- Award Ribbons from TI.

Award: Monsoon Dhamaka

Criteria:

- Add 10 new, dual or reinstated members between 1st Jul 2023 and 30th Sep 2023. No transfer or charter members to be included

Eligibility:

- Applications and payments to TI before 30th Sep 2023.

Process:

- Verified through dashboard.

Recognition:

- Award for the President and VP-Membership of first term.

Award: The Power of Three

Criteria:

- New or Dual or Reinstated member joining a club between 1st Jul 2023, to 30th Sep 2023 and paying membership fees till 30th Sep 2024.

Eligibility:

- Membership start date should be 1st Jul 2023, or 1st Aug 2023, or 1st Sep 2023, and paid to TI before 30th Sep 2023.

Process:

- Data will be verified from the membership report.

Recognition:

- TI branded merchandise for the member.

Award: The Power of Two

Criteria:

- New or Dual or Reinstated member joining a club between 1st Jul 2023 to 31st Jul 2023 and paying membership fees till 31st Mar 2024.

Eligibility:

- Membership start date should be 1st Jul 2023 and paid to TI before 31st Jul 2023.
- Member is not eligible for “The Power of Three” award

Process:

- Data will be verified from the membership report.

Recognition:

- TI branded merchandise for the member

Award: Torch Bearer Expert

Criteria:

- Clubs in which minimum 21 members do annual renewals, during the September renewal cycle before 30th Sep 2023.
- Not eligible for Torch Bearer Category 2,3 and 4.

Eligibility:

- Membership fees needs to be paid for 1st Oct 2023 to 30th Sep 2024.

Process:

- Data will be captured from the membership report.

Recognition:

- Standee for the club.
- TI-Merchandise for Member

Award: Torch Bearer Practitioner

Criteria:

- Clubs in which minimum 15 members do annual renewals, during the September renewal cycle before 30th Sep 2023
- Not eligible for Torch Bearer Category 3 and 4.

Eligibility:

- Membership fees needs to be paid for 1st Oct 2023 to 30th Sep 2024.

Process:

- Data will be captured from the membership report.

Recognition:

- Plaque for the club.
- TI-Merchandise for Member

Award: Torch Bearer Apprentice

Criteria:

- Clubs in which minimum 9 members do annual renewals, during the September renewal cycle before 30th Sep 2023.
- Not eligible for Torch Bearer Category 4.

Eligibility:

- Membership fees needs to be paid for 1st Oct 2023 to 30th Sep 2024.

Process:

- Data will be captured from the membership report.

Recognition:

- Lectern for Club
- TI-Merchandise for Member

Award: Torch Bearer Beginner

Criteria:

- Clubs in which minimum 4 members do annual renewals, during the September renewal cycle before 30th Sep 2023.

Eligibility:

- Membership fees needs to be paid for 1st Oct 2023 to 30th Sep 2024.

Process:

- Data will be captured from the membership report.

Recognition:

- TI-Merchandise for Member

Award: Old is Gold Award

Criteria:

- Retain and renew 70% base Membership Count by 15th Oct 2023

Eligibility:

- Club to be in good standing, and base membership needs to be 15 or above.

Process:

- Data will be captured from the membership report.

Recognition:

- TI branded Merchandise for all ExCom members.

Award: Rising Star Award

Criteria:

- Clubs with membership 8 to 19 as of 1st Jul 2023 adding net 5 or more members by 15th Oct 2023

Eligibility:

- Membership start date should be 1st Jul 2023 or 1st Aug 2023 or 1st Sep 2023.

Process:

- Verified through dashboard.

Recognition:

- Award for the Club.

Award: Fantastic Four Award (Biweekly in Q1)

Criteria:

- Add 4 new/dual/reinstated members for biweekly starting from 1st Jul 2023 till 30th Sep 2023.
- No transfer or charter members to be included

Eligibility:

- Applications and payments to TI before 30th Sep 2023

Process:

- Data will be captured from the membership report.

Recognition:

- Award for all eligible Club(s).

Award: Successful Club Coach

Criteria:

- Coaches who help assigned clubs getting distinguished and above status by 30th Jun 2024

Eligibility:

- Coaches from previous year as well as appointed this year
- Coaches should attend Coach training Program
- Not eligible for Club Coach Spirit Award.

Process:

- Verified through dashboard.

Recognition:

- Award for Coach(es).

Award: Club Coach Spirit Award

Criteria:

- Coaches who help assigned clubs getting 5 DCP goals or net growth of 3 members by 30th Jun 2024

Eligibility:

- Coaches from previous year as well as appointed this year
- Coaches should attend Coach training Program

Process:

- Verified through dashboard.

Recognition:

- Award for Coach(es).

Award: Sponsor Award

Criteria:

- Individual member who Sponsors new members (Counts min 4 to max 8) by starting from 1st Jul 2023- 30th Jun 2024

Eligibility

- Not applicable for chartering Club members.

Process:

- Club President to send screenshot of membership sponsorship done by member through email to Area Director and Award Chair on awards@district125.org.

Recognition:

- Award for Individual Sponsor

Award: Super Sponsor Award

Criteria:

- Individual member who Sponsors new members (at least 9 members) by starting from 1st Jul 2023- 30th Jun 2024

Eligibility

- Not applicable for chartering Club members.

Process:

- Club President to send screenshot of member sponsorship done by Individual member through email to Area Director and Award Chair on awards@district125.org by .

Recognition:

- Award for Individual Sponsor
